I **understand and agree** to the following:

1. Participants are expected to supply their own tables, chairs, canopy, etc. and any supplies necessary for booth operation.
2. All tents are expected to be securely weighted or staked to prevent the tent from becoming air-borne or hazardous to others.
3. Vendors should also ensure that their product display is secured.
4. If the participant is bringing a tent/canopy, such should fit within the booth space paid for in this agreement.
5. You will be assigned a specific location the day of the event. You agree to the location identified and provided.
6. Vendors must be set up no later than 9:00 am on March 9th.
7. All vehicles must be parked in assigned areas.
8. After event, all participants must clean up their space completely, taking all unused product, boxes, supplies, etc. with you. No trash or debris of any kind may be left.
9. **No artisan, crafter or organization will be allowed to sell any Confederate items. Push Cart vendors cannot sell any Confederate items, offensive sprays, fake cigarettes or cigarette lighters, laser light pens or other offensive items. Artisans, crafters and organizations will be allowed to play CD's or music to promote their sales (only within the vicinity of their vendor space).**
10. **In the event any such items are being displayed or sold during the festival and/or music being played beyond their vendor space, the persons will be asked by Festival Staff to remove items aforementioned or turn their music down. Should the Festival Staff have to go back to the said vendor the second time, a police officer will be with them and the police will escort them from the premises immediately.**
11. **Participants are encouraged to decorate their space with St. Patrick's Day/Themed decorations.**
12. Please do not make any changes in your list of products without approval of the directors, Karen Coleman, Shelley Sarvis, and Heather Solomon.
13. All vendor fees are NON-refundable.
14. **Please have a copy of your SC retail license on hand the day of the event.**
